Summary Results of the Survey on Car Rental Companies and Taxi Service Agencies in the Year 1399¹

In the month of Aban² of the year 1399 the Statistical Centre of Iran implemented the “Survey of Car Rental Companies and Taxi Service Agencies” from the survey series of “The National Transportation Establishments” with the aim of providing the data required for the compilation of national and regional accounts in the transportation sector for the year 1398 in the activities related to these establishments. Before, the Statistical Centre of Iran also implemented this Survey in the years 1379, 1380, 1383, 1386, 1390, 1392 and 1395.

In the implementation of this survey in the year 1399, information collection was a face-to-face interview and using a questionnaire. The generalization of the results of the mentioned survey to the total statistical population shows that:

- There were 25592 car rental companies and taxi service agencies nationwide in the year 1398.
- There were 34658 employees in these establishments (Car Rental Companies and Taxi Service Agencies) which shows that on average, between one to two persons were working in each establishment. Out of this number, 22.9 percent were wage and salary workers and 77.1 percent were unpaid wage and salary ones
- In the given period, the compensation of services provided by workers in car rental companies and taxi service agencies was 1408 billion rials which shows that on average, 14.8 million rials was monthly paid to each wage and salary worker.
- In the year 1398, the value of intermediate consumption of car rental companies and taxi service agencies was about 3009 billion rials. Out of this number, 3.6 percent was paid for stationery, paper and printed forms, newspaper, publications,, press matter and packaging supplies, 21.6 percent for water, electricity, natural gas and other fuels, 5.6 percent for communication and transportation costs, 3.2 percent for commercial insurances (theft-insurance, fire insurance,etc.), 43.9 percent for building rental, 7.9 percent for minor repair of capital assets, and 14.2 percent for other intermediate consumptions. ¹ Accordingly, the value of intermediate consumption of each establishment was, on average, about 118 million rials.

¹ . It is the Iranian year which usually begins on the day of 21 March of Gregorian calendar. To find the corresponding year of Gregorian calendar, add 621 or 622 (depending on the time of the year) to a solar Hijri year. For example, the corresponding year of the year 1400 in Gregorian calendar is (21 March 2021-20 March 2022).

- In the year 1398, the outputs value of car rental companies and taxi service agencies was more than 32360 billion rials. Out of this number, 98.9 percent was paid for “fare, commossion and charge for passenger transporation”, and 1.1 percent for other outputs. Based on these figures, on average, the outputs value of each establishment was 1264 billion rials.
- According to the findings of the survey implementation in the studied perriod, the value-added of the car rental companies and taxi service agencies was 29351 billion rials showing that value added of each establishment was 1146 million rials which has increased by 1.9 times in comparison with the results of the previous survey (the year 1395).
